

Explanation describing how procurement by competitive means is either not practicable or advantageous to the State: Contract was awarded as a "Discretionary" procurement in 2003 prior to the time when HHSC was subject to state procurement code HRS §103D. HHSC desires to re-issue a formal RFP for the pathology services provided under this agreement and a solicitation is estimated for release in March 2018 following the completion of a third party assessment of HHSC laboratory operations. This one-year exemption extension will allow for uninterrupted, critical services during the competitive solicitation and award of a new contract.</p>																					
<p>9. Details of the process or procedures to be followed in selecting the vendor to ensure maximum fair and open competition as practicable: HHSC full and open competition will follow the completion of a third-party assessment of the HHSC laboratory operations.</p>																					
<p>10. A description of the agency's internal controls and approval requirements for the exempted procurement: The exemption request is reviewed by HHSC senior management in accordance with HHSC policies and procedures. The President/CEO of HHSC (or delegated CPO) approves the exemption requests covering more than one facility and in accordance with internal procurement policies and procedures. HHSC policies and procedures will be followed and periodic reviews of the contract action will be performed.</p>
