Explanation describing how procurement by competitive means is either not practicable or not advantageous to the State:

Historically, HHSC has tried other companies that have attempted to provide this service. The overall results have been negative. There are two examples of having to send scopes back to the manufacturer for repair after other service centers attempted their "repair". This contributes to unforeseen costs and untimely delays.

The Scope Exchange is the only company to stand the test of time in being able to deliver consistent, quality workmanship acceptable to all HHSC facilities. Also over the past year we have made five purchases of new scopes manufactured by The Scope Exchange. These high quality scopes were purchased for \$990 each. Less than half the price of most other manufacturers. The Surgical staff has been very happy with these scopes. And now we are in a position where The Scope Exchange is unquestionably the best source of repair because they are in fact the manufacturer.

Repair of endoscopic and surgical instruments is extremely tedious and delicate work. It is not a realistic goal at this time to find another company as capable at such a reasonable price.

The facility has used the other available vendors and has determined that they cannot meet the needs of the facility in obtaining fast and correct repairs to this vital equipment.
