8. Explanation describing how procurement by competitive means is either not practicable nor advantageous to the State:

Kona Community Hospital does not currently have a vendor agreement in place for locems placement. The previous agreement with CompHealth expired on 04/05/06 and an HHSC wide Request for Proposal was made locems placement. Proposals are due on 5/15 and an evaluation of the proposals is to follow. We estimate that vendor agreements will be in place by August 2006 (following Board review and approval). In the past, CompHealth has successfully identified locems that are credentialed with the hospital. This is a request to continue utilizing CompHealth and other vendors for the purposes of locems placement as an interim measure pending the award of HHSC wide agreements for placement of locems.

9. Details of the process or procedures to be followed in selecting the vendor to ensure maximum fair and open competition as practicable:

Hawaii Health Systems has advertised an RFP and anticipates entering into an agreement with several vendors for placement of locems. In the meantime, locem agencies will be contacted and a determination made if the vendor can meet our need for locem

10. A description of the agency's internal controls and approval requirements for the exempted procurement:

This exemption shall be from HRS, Section 103-303. All other guidelines, rules and policies under Chapter 103D shall be upheld. HHSC policies and procedures will be followed and periodic reviews of the contract action will be completed.
