Hilo Medical Center (HMC) requires expert assistance in interpreting and operationalizing the standards for Joint Commission on Accreditation for Healthcare Organizations (JACHO) for a variety of health care programs including but not limited to acute care and home care. HMC contracts with independent consultants to provide the expertise to assess performance relative to JACHO standards, and provide guidance & staff education to address potential noncompliance issues as well as track performance for periodic reviews.

 Explanation describing how procurement by competitive means is either not practicable or advantageous to the State:

HMC executed 1 year contract with TP Williams in April 2005 inclusive of option to extend the agreement for two additional one-year periods through April 2008. As JACHO consulting services require a lengthy planning/implementation process to provide expertise needed to maintain JACHO accreditation, it would be neither practicable nor advantageous to the State to initiate a new competitive procurement action at this time. Before termination of this extended contract HMC will conduct a new procurement process compliant with 103D.

9. Details of the process or procedures to be followed in selecting the vendor to ensure maximum fair and open competition as practicable:

HMC initiated procurement of a JACHO consultant through a request for quotations in January 2005, receiving 4 proposals. The consultant selected, T.P. Williams has an existing relationship with the hospital and staff. The RFQ was conducted concurrent with implementation of new legislation requiring HHSC to comply with Chapter 103D, HRS. The service is essential and it would take time for a new vendor to develop the knowledge of HMC's operations. Thus conducting a new request for proposals at this time could cause unwarranted disruptions to the current compliance preparation activities and could result in negative impacts on the facility's accreditation.
