5. <b>Description of goods, services, or construction:</b> This Request to Amend Exemption 11-011 is sought to include website hosting services for four HHSC facilities which were not included in the initial Exemption Request. The facilities not included in the original request include website hosting services for three Maui region facilities and the Kona Community Hospital website (a total of two websites for the four HHSC facilities). The websites were designed by McMurry using their proprietary software	
6. <b>Scope of work for the contract is revised as follows:</b> Subsequent to approval of Exemption 11-011, the Contractor completed website design for the four facilities noted above utilizing its proprietary software "WebEdge". The Contractor has offered HHSC significant savings (a 20% hosting fee reduction to the Maui Region and a 30% monthly hosting fee reduction to KCH) as an incentive to consolidate its hosting services into a single HHSC Agreement. For technical and community/patient support reasons, HHSC requires the same website interface and functionality to maintain consistent design look, feel, performance and single hosting environment for HHSC web sites across all its facilities.  This request also amends anticipated Exemption 11-011 "Term of Contract" as follows: <b>From:</b> Date of Contract Execution <b>To:</b> Three Years from Date of Contract Execution  Original Contract Price: \$350,000 Amended Contract Price: \$405,000	
7. <b>Reason:</b> This amendment is necessary because the initial Exemption Request did not include four facilities which were under regional arrangements, and which HHSC seeks to now move into its Corporate contract.
