Explanation describing how procurement by competitive means is either not practicable or advantageous to the State: Stroudwater Associates has the requisite experience, qualifications, and knowledge necessary to update a report they wrote in December 2009 with delivery to the Hawaii State Legislature in 2010, extensively evaluating HHSC. Due to the dynamic nature of the healthcare industry, it is timely to update the 2009 report, specifically focusing on system initiatives to increase financial and operational results, and the governance structure, roles and responsibilities of the corporate and regional boards, and management teams.
