# Minimum Qualification Specifications for the Class:

# REHABILITATION SERVICES MANAGER

#### Education Requirement:

A Bachelor's degree from an accredited college or university in Speech and Hearing, or a graduate of a school of Physical Therapy recognized by the U.S. Department of Education or the Council on Post-Secondary Accreditation or a graduate of a school of Occupational Therapy approved by the American Occupational Therapy Association, Inc. in collaboration with the American Medical Association.

<u>Experience Requirement</u>: Three and one-half (3-1/2) years of responsible professional administrative experience in management of rehabilitation programs.

<u>Supervisory Experience</u>: One (1) year of supervisory work experience which demonstrated the applicant's knowledge of and ability to apply the principles, practices, techniques and methods of supervision including: (1) planning, organizing and directing the work of others; (2) assigning and reviewing work; (3) advising others on difficult work problems; (4) timing and scheduling work; and (5) training and developing employees.

#### Substitutions Allowed:

Possession of a master's degree from an accredited college or university in Physical Therapy, Occupational Therapy or Speech Therapy, may be substituted for one (1) year of professional work experience.

#### Quality of Experience:

Possession of the required number of years of experience will not in itself be accepted as proof of qualification for a position. The applicant's overall experience must have been of such scope and level of responsibility as to conclusively demonstrate that he/she has the ability to perform the duties of the position for which he/she is being considered.

#### Selective Certification:

Specialized knowledges, skills and abilities may be required to perform the duties of some positions. In such positions, applicants may be restricted to those who possess the pertinent experience and/or training required to perform the duties of the position.

#### PART II REHABILITATION SERVICES MANAGER

Departments requesting selective certification must show the connection between the kind of training and/or experience on which they wish to base selective certification and the duties of the position.

#### **Physical Requirements:**

Applicants must be physically able to perform, efficiently and effectively, the essential duties of the position which typically require the ability to read without strain printed material the size of typewritten characters, glasses permitted, and the ability to hear the conversational voice, with or without a hearing aid, or the ability to compensate satisfactorily. Disabilities in these or other areas will not automatically result in disqualification. Those applicants who demonstrate that they are capable of performing the essential functions of the position will not be disqualified under this section.

Any condition which would cause applicants to be a hazard to themselves or others is cause for disqualification.

Any disqualification under this section will be made only after a review of all pertinent information including the results of the medical examination, and requires the approval of the VP/Director of Human Resources.

### Mental/Emotional Requirements:

All applicants must possess emotional and mental stability appropriate to the job duties and responsibilities and working conditions.
