This Device is used to de clot Dialysis Access Grafts/Fistulas.

The 5Fr Catheter sheaths the fragmentation basket. Catheter allows smooth placement into graft and clot. Then, the 9mm fragmentation basket is advanced out of catheter. The Rotator Drive Unit is activated to spin the basket @3000 RPM which macerates the thrombus (clot). Catheter and Fragmentation basket materials/design allows excellent visualization of tip under fluoro.

The Large Bore Sidearm and stopcock on this introducer sheath provides the pathway for the clot to be aspirated out.

All together this has been a very effective process.

This is the only device our physicians will use due to its unique safety features.

REQUEST FOR SOLE SOURCE (Cont.)

How the unique features, characteristics, or capabilities are essential for the agency to accomplish its work:

We are the only Angio Suite on the Island. We have a high population of patients who are on Dialysis. A high percentage of these patients have grafts/fistulas that clot off resulting in not being able to get Dialysis. These patients are sent to us in Angio first as an outpatient procedure. This device is easy to use. It is cost effective in declothing dialysis access grafts with or without the use of a thrombolytic medication. This is important especially when a thrombolytic med is contraindicated for a patient—the PTD is a safe option. Device is highly effective in clearing the graft and restoring flow so dialysis can be done. Procedure done as an outpatient helps reduce the pt needing to go to the Operating room or being admitted for further intervention.
